### Message from the Chair

### Municipal elections are over, and oh, what a night!

What an election night!

The Town of Bernalillo continued to be a stronghold

in Sandoval County. The field was full of races with only Democratic candidates.

Incumbent mayor, Jack Torres, won with 84 percent of the vote. For Town of Bernalillo Councilor Position 1, Vincent Montoya won with 73 percent of the vote. Dale Prairie won with 52 percent for the second councilor position.

Corraleños worked hard during this election cycle, and it showed! Mayor-elect Jim Fahey brought home 60 percent of the vote. Councilor Position 4, John Alsobrook, squeaked by Courtney Eichorst (both Democrats) with a 51 percent to 49 percent win. Rick Miera came in at 55 percent for a comfortable win in Councilor Position 1.

My absolute favorite win of the Corrales election goes hands down to Mel Knight for trouncing her Trump-loving opposition with an astounding 72 percent of the vote! (Way to send a message, Corrales!)

Ward D Chair, Nandini Kuehn, worked hard organizing her ward with much help from the many active Democrats in Corrales.

Unfortunately, our strong Rio Rancho mayoral candidate, Barbara Jordan, suffered a loss. Barbara ran a good race and worked hard to defeat the entrenched "good ole boy" network in Rio Rancho.

Municipal Judge candidate Jonathan Muñiz made a splash in spite of entering the race at the eleventh hour. Rio Rancho City Council District 3 candidate, Joshua Jones, came in second, but none of the candidates reached the fifty percent threshold necessary to win; stay tuned for the runoff election in April.

Finally, City Councilor District 5 incumbent, Karissa Culbreath, won her seat with 56 percent of the vote.

The Democratic Party of Sandoval County (DPSC) will be reviewing the data and conducting postmortems in order to make informed decisions about races in the future. We have much organizing to do, especially outside of the Town of Bernalillo and the Village of Corrales.

It is not easy to run for office, and we thank all candidates for stepping up to serve our communities.

### PERMANENT FUND FOR EARLY CHILDHOOD EDUCATION

The proposed Constitutional Amendment would approve a 1.25% withdrawal annually from the Land Grant Permanent Fund, valued at around \$20 billion. Most of the funds would go to early childhood education, with some going toward the public-school permanent fund. If passed, it would mean increased funding for education of approximately \$250 million each year.

### Making a Difference in Sandoval County

### **County Commissioner** Katherine Bruch uses discretionary funds for generous donation to Feed Rio Rancho Kids

Feed Rio Rancho Kids received a \$5,000 grant from the Sandoval County Commission to support expansion of the program and help meet the needs of area children who are food-deprived.

"This grant makes it possible for us to assist in expanding the program to other parts of the county, to purchase a hand truck and shelving for storage and helps us meet the rising cost for food," said Karen Schafer, of the Sandoval County Federation of Democratic Women. "It is validation for our volunteers that the work we do is appreciated and essential."

County Commissioner Katherine Bruch made the

allocation, received in January, from her commissioner discretionary funds.

"We do have some significant issues with food security around some of the children in our schools in all our (commission) districts," she said. "... It's just really something that we have not taken as close of a look at as we need to."

Bruch said she's hoping to work with Feed Rio Rancho Kids to identify a nonprofit to expand that mission into Bernalillo schools.

A project of Sandoval County Federation of Democratic Women and the Unitarian Universalist Westside Congregation, Feed Rio Rancho Kids began in 2019. Volunteers deliver snack packs through the schools on Fridays to provide food for students in need over the weekend.

Schafer said the group keeps the schools served

confidential and works with social workers for privacy, so even volunteers don't know the identity of the students.

The first semester of this school year, the group provided 820 snack packs. Volunteers also provided new winter coats and 10 new backpacks filled with school supplies.

Volunteer Virginia Breeding and Rio Rancho City Councilor Karissa Culbreath made the coats and backpacks possible.

Ward A is also very blue!

President Biden won all but two precincts in this ward. Sandia Pueblo voted blue by more than 50 points.

Despite this, Bernalillo has low political engagement. Many of its precincts and County Central Committee seats remain unfilled. No serious organized Democratic groups exist within the town similar to those in Placitas and Corrales. Many residents are not registered to vote, and those who are registered turn out in low numbers. There is clearly much opportunity to generate significant additional Democratic votes.

With greater engagement, Bernalillo could become pivotal to outcomes within the county and even the state.

> Today, six Bernalillo precincts have chairs, and engagement is growing. More people from Ward A are becoming aware of DPSC activities, and the party remains hopeful that this ward can achieve the same level of organization

# What Do State Pre-Primary Convention Delegates Do?

The <u>2022 Democratic Pre-Primary</u> <u>Election Nominating Convention</u> will be held on Saturday, March 5, 2022. DPNM is required to hold the Pre-Primary Convention per state law and DPNM Rules.

Delegates from all New Mexico counties will vote for their preferred Democratic candidate for each statewide and federal office up for election in 2022. Each candidate who receives 20 percent or more of the votes will be placed on the primary ballot. In each contested race, the candidate who receives the most convention delegate votes will be listed first on the primary ballot, with other candidates listed in descending order.

Convention delegates will also consider adoption of a new Democratic Party platform.

### **Order of Business**

- 1. Call to order by the State Chair.
- 2. Reading of the Call.
- 3. Credentials report from the Judicial Council.
- 4. Introduction of temporary convention officers selected by the State Chair. (Voice vote) Election of permanent officers of the convention.
- 5. Presentation of the 2022 DPNM Platform by Members of SPARC.
- 6. Candidates for statewide and federal offices address convention delegates.

In January, we welcomed Nandini Kuehn, Ward D and in February, Judy De Atley, Ward K and Mitchell Freedman, Ward G.

Chair Alex Piland, Vice Chair Isaac Chavez, and Second Vice Chair Tweety Suazo reported on their recruitment efforts to fill additional ward chair positions. We have 9 of the 13 wards covered but still have vacancies in Wards A, E, H, and M. If you live in any of these wards, consider becoming chair. Ward chair is an elected position. As county party chair, Alex appoints ward chairs to vacant positions between elections as she is now doing. The next election for all ward chair positions will be held in 2023.

Isaac reported on the two scheduled municipal candidate forums sponsored by DPSC. For First Friday at The Range on February 12, the Town of Bernalillo mayoral candidates and three of the four candidates running for two town council positions—all Democrats—spoke and answered questions.

For Second Saturday at M'tucci's Moderno, we heard from the Democrats running for office in Rio Rancho—one for mayor, one for municipal judge, and two for city council positions.

Vaccinations and masks were required at both events, which were very well attended. The sessions were also livestreamed and posted on <u>Facebook</u> and our website.

The League of Women Voters of Central New Mexico sponsored a candidate forum in Corrales with both Democratic and Republican candidates.
